- 2. Provide, deliver, and install **another** leased line connection to the proposed server room at the Library, Databank Bldg. DOE.

The Winning Bidder shall provision two lines – one to the existing server room located at the NPTL Bldg. (NPTL Line) and the new server room located at the Databank/Library (Databank Line). Immediately after the award, the Winning Bidder shall activate the NPTL Line for 1 Gbps internet access. However, upon the transfer of the server to the Databank/Library, the Winning Bidder shall activate the Databank Line for 1 Gbps internet access and deactivate the NPTL Line. Transfer to the new server room will be within 2024.

### **Shuttle Vehicles and Destinations:**

Two (2) Aircon Shuttle Buses, year model CY 2019 up to present, minimum of Forty-five (45) seating capacity with forty (40) seats (2 x 2 per side) with seat covers, seat belts, and five (5) fixed seats at the back, fire extinguisher, comfortable leg-room (at least 28 centimeters of space from front-end of the seat to the back of the next seat) and width of at least 44 centimeters, fully airconditioned at the range of 24 to 25 degrees centigrade, with window curtains and audio and video system, having automatic door closer at the front and emergency exit at rear-end side, to be provided with complete signages/markings as "DOE Employees Shuttle Service" at the front and rear wind shields, driven by duly uniformed, neat-in-appearance, courteous and responsible drivers with complete IDs and communication system;
- b. Seven (7) Mini Buses/Aircon Coasters, year model CY 2019 up to present, minimum of Thirty-three (33) seating capacity with twenty-eight (28) seats (2 x 2 per side), with seat covers, seat belts, plus five (5) fixed seats at the back, fire extinguisher, comfortable leg-room (at least 28 centimeters of space from frontend of the seat to the back of the next seat) and width of at least 44 centimeters, fully air-conditioned at range of 24 to 25 degrees centigrade, with window curtains and audio and video system, having automatic door closer and emergency exit rear-end side, to be provided with complete sign-ages/markings at the front and rear wind shields as "DOE Employees Shuttle Vehicle", and driven by duly uniformed, neat-in-appearance, courteous and responsible drivers with IDs and communication system;

\*The Aircon Shuttle Busses shall service the routes of Monumento in Caloocan and Salawag in Cavite Via Molino, Alabang in Muntinlupa and Sucat Exit; Aircon Mini Bus/Coasters shall service Lawton/Welcome Rotunda in Manila, SM Masinag in Marikina, SM Fairview, SM Calamba, San Pedro in Laguna thru Carmona exit and Bicutan exit in Taguig, SM Imus in Cavite (via CAVITEX/Aguinaldo Highway/Tirona Highway) and Bulacan area (via Sta Rita Exit Marilao Exit, Meycauayan Exit and Paso De Blas) to pick-up passengers in the morning and ferry back in the afternoon to/from DOE at Energy Center, Bonifacio Global City (BGC) in Taguig City.





\*\*Bids are inclusive of toll fees, other fees, taxes, drivers' salaries and allowances, insurance of riding employees (each riding employee shall be covered with a maximum of Php150,000.00 personal accident insurance for a total of Three Hundred Twenty One (321) seating/riding employees in the nine (9) shuttle vehicles x Php150,000.00 equivalent to P48,150,000.00 personal accident insurance plus Php1,000,000.00 property damage for a total of Php49,150,000.00 Comprehensive General Liability (CGL) insurance.
