Whereas, Section 5 of Republic Act No. 7638, as amended by Section 37 of Republic Act No. 9136 or the Electric Power Industry Reform Act of 2001 (EPIRA), mandates the Department of Energy (DOE) to, among others, 1) ensure the reliability, quality and supply of electric power, and 2) establish and programs for the exploration, administer transportation, marketing, distribution, utilization, conservation, stockpiling and storage of energy resources of all forms, whether conventional or nonconventional.

In fulfilling its mandate, the agency is overseeing the functions of the following attached agencies:

# National Power Corporation (NPC)



NPC is the government power generation arm that provides power generation and its associated power delivery systems in areas that are not connected to the transmission system, through the Small Power Utilities

Group (SPUG). It is also tasked to manage the watersheds and dams, to operate and maintain the generation assets of the government being privatized pending their disposal.
