DEPARTMENT ORDER NO. DO2023-10-0023 *pl*

**PROVIDING GUIDANCE ON THE FINAL TRANSFER OF THE REMAINING
DOE - ADMINISTERED FINANCIAL BENEFITS UNDER
ENERGY REGULATIONS NO. 1-94 (ER 1-94)**

WHEREAS, on 26 July 2018, the Department of Energy (DOE) issued Department Circular (DC) No. DC2018-08-0021, titled "Providing for the Amendments to Rule 29 Part (A) of the Implementing Rules and Regulations of Republic Act No. 9136", which took effect on 23 August 2018, to provide the rules and guidelines redirecting the administration of the financial benefits under the ER 1-94 Program to promote efficiency in the government processes and ensure that the financial benefits are properly allocated and availed of;

WHEREAS, on 14 November 2019, the DOE issued Department Order (DO) No. DO2019-12-0021, titled "Creation of a Reconciliation Team for the Implementation of Department Order No. DO2019-01-0001", which provided the policy for the DOE to remit the unclaimed ER 1-94 Funds to the Bureau of Treasury (BTr) not later than 30 June 2020;

WHEREAS, the remittance of the unclaimed ER 1-94 Funds in the DOE to BTr was held in abeyance pursuant to DC No. DC2020-04-0008 dated 16 April 2020, titled "Rationalizing the Utilization of Energy Regulations No. 1-94 (ER 1-94) Funds by Host Local Government Units (LGUs) in Response to Coronavirus Disease 2019 (COVID-19) Public Health Emergency", which allowed the temporary use of all available ER 1-94 Funds for projects intended to contain, mitigate and eliminate the spread of COVID-19, particularly in the communities hosting energy projects, until the lifting of the State of Public Health Emergency and/or extension period provided by the DOE;

WHEREAS, on 19 July 2021, the DOE issued the "2nd Advisory for the Implementation of DC No. DC2018-08-0021 and Its Supplemental Policy Issuances" which provided further guidance in relation to Section 2.3 of DO No. DO2019-12-0021 that failure of the designated beneficiaries to claim the ER 1-94 Funds due to absence of the required Interest Bearing Current Account (IBCA) and/or upon advise to the DOE that it will not further utilize their allocated share, their ER 1-94 Funds shall be deposited by the DOE to BTr within sixty (60) days from the lifting of the declaration of the State of Public Health Emergency;

WHEREAS, on 8 May 2023, the DOE issued an Advisory on the "Operation of Section 10 (Sunset Clause) of DC No. 2020-04-0008", which declared the conclusion of the rationalization of ER 1-94 Funds for COVID-19 Projects pursuant to said Circular and outlined the process and requirements relative to the utilization and liquidation of the allocated Funds and the completion of remaining projects sponsored by the same;

WHEREAS, on 20 July 2023, the DOE issued DO No. DO2023-07-0021 which provided supplemental guidelines for the Distribution Utilities (DUs) on the streamlined procedures for the transfer of the existing accrued Electrification Fund (EF) pursuant to DO No. DO2019-01-0001;

WHEREAS, on 21 July 2023, the Office of the President issued Proclamation No. 297, series of 2023, lifting the State of Public Health Emergency throughout the Philippines;

NOW, THEREFORE, in consideration of the above premises, the DOE hereby provides guidance on the final transfer of ER 1-94 Funds to the concerned designated beneficiaries and the remittance of the unclaimed amount to BTr not later than **31 December 2023**. For this purpose, the following shall be observed:

Section 1. Responsibilities for the Validation and Transfer of Existing/Remaining Fund

- 1.1. The Electric Power Industry Management Bureau (EPIMB) shall disseminate this Order and ensure the compliance of concerned designated beneficiaries with the requirements for the timely and orderly transfer of funds as provided in this Order.
- 1.2. The Financial Services (FS) and Administrative Services (AS) shall validate, on a per Generation Company basis, the pertinent portion from the ER 1-94 Funds for each designated beneficiary and transfer such allocations to the respective accounts of the beneficiaries.

The amount to be remitted to BTr shall be comprised of all unclaimed ER 1-94 Funds in the DOE, including the remaining Interest Earnings after settlement of obligations for completed electrification projects.

- 1.3. The National Electrification Administration (NEA) shall ensure compliance of electric cooperatives with the requirements for the transfer of funds in accordance with this Order.

Section 2. Compliance with Mandatory Requirements for the Transfer of Existing/Remaining Fund

Not later than **15 November 2023**, all concerned Host and Non-host LGUs and designated DUs as listed in Annex "A" of this Order, shall submit the following:

- 2.1. IBCA for Host LGU/s and designated DUs, or General Fund Account (GFA) for Non-Host LGU/s; and
- 2.2. Liquidation Report with supporting documents for unliquidated ER 1-94 Funds previously availed, if any.

Section 3. Process for the Transfer of Existing/Remaining Fund

- 3.1. Within ten (10) working days from receipt of the complete requirements, the EPIMB shall prepare the pertinent documents, including the Disbursement Vouchers and other supporting documents, for the transfer of ER 1-94 Funds to the concerned beneficiaries. Notwithstanding, the final transfer shall be subject to validation by the FS.

- 3.2. Not later than **22 November 2023**, the EPIMB shall endorse to the AS and FS the complete list of designated beneficiaries that did not comply with the required submission of bank certificates and/or liquidation reports, as applicable. Based on the endorsed list, the FS and AS shall thereafter validate and determine the final amount for remittance to the BTr.
- 3.3. Not later than **31 December 2023**, the AS shall ensure that all validated remaining funds are completely and accordingly remitted to the designated beneficiaries and the BTr.

Section 4. Final Provisions

Not later than **31 January 2024**, the following shall be undertaken:

- 4.1. Closing of the DOE ER 1-94 Trust Account by the AS in coordination with FS; and
- 4.2. Preparation and submission to the Office of the Secretary of a report on the implementation of this Order by EPIMB, in coordination with AS and FS.

The accomplishment of Items 4.1 and 4.2 above shall deem this Order complied, unless otherwise declared by the Secretary.

Section 5. Repealing Clause

All issuances inconsistent with any provisions of this DO are hereby repealed or amended accordingly.

Section 6. Effectivity

This DO shall take effect immediately after its posting on the DOE website.
